Barnstable Probate and Family Court. Attorney Long started at the Court as the First Assistant Register on November 15, 2021.



Hon. Lisa Edmonds was appointed to First Justice of Falmouth District Court on January 21, 2021. The COVID pandemic overshadowed what would normally be a celebrated occasion and wonderful addition for Falmouth District Court. Judge Edmonds is committed to fostering a court where every person is treated with dignity, respect, and fairness. In her new role, she is presiding over the Falmouth Recovery Court.


Judge Edmonds graduated from UMASS
Boston, magna cum laude, in 1992 with a degree in Political Science. She went on to graduate, cum laude, from Suffolk Law School in 1995. She soon began her career as
Assistant District Attorney for the Cape and Islands District Attorney's Office in 1996.

as a board member of the Women's Bar Association for many years, prior to her appointment. Judge Edmonds has received many accolades over the years, including, Massachusetts Lawyer's Weekly "Top Wo of the Law" in 2013, and Massachusetts B Association's 2014 Access to Justice Awar

She has had extensive trial experience in the Juvenile, District and Superior Courts, serving as Chief District Court Prosecutor from 2001 to 2006. In her role as a juvenile prosecutor,

she created a juvenile diversion program which is now a staple in our criminal justice system. In 2009, Judge Edmonds became the Chief of the Domestic Violence Unit where she supervised domestic violence prosecutions in district and superior court. In that role, she created a High Risk Task Force, working with stakeholders in the community to target cases that posed the greatest risk of homicide or escalation in violence, with the goal of prevention and protection. She proudly served as a board member of the Women's Bar Association for many years, prior to her appointment. Judge Edmonds has received Massachusetts Lawyer's Weekly "Top Women of the Law" in 2013, and Massachusetts Bar Association's 2014 Access to Justice Award.


