



Dear Association Members: Can You Help an Asylum Applicant?

My office has met with representatives of the Immigration Resource Center at Community Action Committee of Cape Cod & Islands (CACCI) to see if lawyers that are not immigration lawyers could assist them in any way to deal with a huge case volume.

In many cases, asylum applicants need assistance in completing paperwork and there are options for attorneys to file Limited Appearances to assist with paperwork. We've started this process in our office assisting an asylum applicant that was here on Temporary Protected Status (TPS). She is employed in hospitality, has two children and was driven out of her home in Haiti by unspeakable violence. The details are horrific. We are learning ourselves as we work our way through the process.

There is also the option to go further and assist at the asylum interview itself.

We are hoping to get together a group of caring lawyers that might even take one case, but anything we can do will help. Once we have a good enough group, we would schedule an educational meeting at CACCI and if we have off cape lawyers, we could also do it as a Zoom meeting.

We are not looking to become immigration lawyers. We're just looking to provide some needed help to good people in need during a humanitarian crisis. If you can help even one family, that's a wonderful thing. If you'd like to be on our list, please email me at bruce@bierlaw.com.
