TIPS FROM THE BARNSTABLE PROBATE AND FAMILY COURT

The Barnstable Probate and Family Court Register's Office provides a walk-in Magistrate's Session for Informal Probates. The sessions are held every Thursday from 9:00 a.m. until 11:00 a.m. You may come to court with your Informal Probate package and have it processed while you wait. The Register's Office accepts one Informal filing at a time per person on a first come first served basis. There is a sign in sheet when you arrive in the Registry Office. As always, you may continue to file your Informal Probates by mail or by hand as you do presently. We hope this service assists you in providing efficient service to your clients.

The Barnstable County Bar Association and the Barnstable Probate and Family Court will host a session for new attorneys on Wednesday, February 8, 2017 at 4:30 pm in the First Session Courtroom. This is an opportunity for new attorneys to meet the Judges and court staff from all of the courts in Barnstable County. Immediately following the session, the Bar Association will host a reception at the Barnstable Tavern beginning at 5:30pm. All are welcome to come to the Barnstable Probate and Family Court and to the Tavern.

A lot going on in Superior Court



I want to thank the bar association for giving me this opportunity to address them with what is going on in Superior Court. We now have two conference rooms on the second floor that can be used by attorneys to have private conversations with their clients or to use to talk with other counsel about resolving a case. The rooms can also be booked for depositions if necessary by contacting myself or Tom Perrino at 508-375-6684 and when you get to the opening message press 6. The two conference rooms are located in the old third session Judge's lobby and the former jury check-in of-fice

There is a new lounge to be used by **attorneys and court staff only** to wait during court recesses, lunch recesses and during jury deliberations. The lounge contains two restrooms and is located in the old victim witness office by the elevator on the second floor.

Civil Pre-Trial conferences are now being held in the third session Judge's lobby on the main floor directly across from the third session courtroom. Attorneys should wait on the bench in the hallway or at the table in the main lobby where you enter the courthouse. Please do not wait upstairs outside the main session courtroom or in the second session.

We have a third session courtroom located in the old Rooms 11 & 12 on the main level. It is being used at present for video bail review hearings and hopefully will eventually be used for a magistrate session as well as other video conferencing events. The room will also be available for use by other courts for non-jury trials and hearings by appointment through myself and the clerk of the requesting court.

I am pleased to announce that a Safe and Secure Waiting area is in place as required by state law. The Safe and Secure Waiting area is only to be used by witnesses for the Commonwealth and victims of crimes. This area is controlled by the DA's office and is located next to the new District Attorney's office space on the second floor (the old probation department office).

We are hoping that the new lock-up project will begin sometime in 2017. This project is long overdue and I will keep the bar updated as this project progresses.

The new trial court recording system (FTR) has been in place in Barnstable Superior Court since May of 2016. The system will be used when we do not have court reporters in the courtroom and eventually full time when court reporters

will no longer be in Superior Court which may happen in 2017. I am available to give a review of the FTR system to any member of the bar as my time allows. This recording system will be in all trial court departments so it is beneficial for all members of the bar to become familiar with the system regardless of where they practice. When the system is being used, anyone can request audio access of non-impounded recordings and request transcripts by going to **us.court.fm**. There is a fee involved in requesting access which at present is \$50.50 per recording which gives you access for up to a year. The recordings can be requested online at any time but will need to be approved by my office and will only be approved during normal business hours of the clerk's office. I am very pleased and proud that Barnstable Superior Court was chosen as a pilot for this service as it shows how well this office is run and the great staff I have working for me.

My office was also chosen to be a pilot for the scanning project. For cases filed in 2015 and after; complaints, answers, judge's decisions and some other paperwork can be viewed online in the attorney portal by attorneys in civil cases. It was a privilege to be chosen for this project as it shows the confidence the trial court administration has in my office and staff. We are adding new scanned documents all the time and I hope that these documents will be available to the public online at some future date to be determined by the powers that be in Boston. At present, criminal documents are not available online and is being looked at by a statewide committee in Boston.

I am also pleased to announce that Barnstable Superior Court clerk's office has been chosen to pilot the new e-filing project that is being tried in several trial court Departments along with Middlesex Superior. We are still working out the final details as to how the e-filing system will coordinate with MassCourts. I will keep the bar updated as things progress.

Introduction of the Consumer Assistance Council (CAC)

HISTORY

Although the Consumer Assistance Council (CAC), Inc. has been located at 149 Main Street, Hyannis for over twenty years it has recently taken on a new Executive Director and in a sense is reborn. The previously little known agency is one of only 18 local consumer groups operating throughout Massachusetts. It is staffed mainly by volunteers who were leaders in their respective private industries or public sector positions before retiring to the area. Marie C. Clougher was recently named its new Executive Director and is the first attorney to head the agency.

The CAC functions under the sponsorship, funding and guidance of the Attorney General of Massachusetts. The CAC is the sole consumer group serving the Cape and Islands. There are no income requirements to use its services and is a great first step in trying to solve consumer issues and complaints.

OBJECTIVES

CAC's primary objective is to help assure relations between sellers of goods and services and consumers are conducted in a fair and equitable manner. To achieve this objective, the CAC conducts programs to educate consumers on their rights under the Consumer Protection Act, Massachusetts General Laws and related rules and regulations. These programs may be carried out through public media, meetings with local groups and individual counseling.

The CAC is also a mechanism for consumers to file formal and vetted complaints concerning specific cases. A trained volunteer is assigned the matter and sets about the consumer advocacy process in order to achieve an equitable resolution of the matter. They use correspondence, telephone calls, personal visits, and face to face mediation to bring the matter to a satisfactory solution. If these efforts fail, they provide referrals to other venues, such as small claims court, alternative dispute resolution centers and/or referrals to the local bar. While most of their energies are directed to helping consumers they seek to protect ethical merchants from unjustified complaints that have no merit as well.

CAC does not represent consumers in court. While they provide information regarding consumer law, mediation and/ or small claims referrals, they do not provide legal advice. Consumers must engage lawyers for that purpose. Once a complainant has engaged a lawyer to handle the underlying matter, CAC will withdraw from the case altogether.

COMMUNITY OUTREACH

Perhaps you belong to a group that could benefit from our expertise? Many groups all over the Cape & Islands have already benefited. Topics include but are not limited to: how to manage credit and/or debt, shoppers' rights, auto lemon laws, auto repair, how to prepare for small claims court, banking tips, scams, home improvement contractor laws, landlord and tenant rights, mail-order or internet purchases, false advertising, credit and collection rules, internet fraud and identity theft. CAC's focus over the past several years has been the service of senior, minority, non-native English speakers and handicapped populations. Its experience and that of the Massachusetts Attorney General's indicates that scam artists are targeting these populations, and CAC has thus prioritized their needs. CAC has direct contact with these target populations through its collaborative outreach and has recently engaged an experienced Portuguese translator and paralegal to enhance its service of this particular population.

BIG ASK

To support and carry out their objectives, CAC is constantly seeking to recruit a qualified staff of motivated volunteers who share its concern and to train volunteers as rapidly and efficiently as possible to competently handle their assigned responsibilities. Volunteers are recruited through solicitation of various community groups such as: Barnstable Bar Association, ESCCI, word of mouth, and through contacts at various state and local agencies and colleges.

Indeed, part of the reason for drafting this article is to reach out to all of you in this regard:

For those BBA members who are winding down their practices, we have had many attorneys continue their great work helping their community through their pro bono work at CAC. It's a great fit for legal minds. Just remember that there are many opportunities to volunteer: public speaking, educational outreach, or straight advocacy. Our volunteer staff is diverse in many ways as they have held a broad range of private and public sector positions including conducting extensive litigation, accounting, working with classified documents, sales, teaching and contract experience to mention a few.
